




# SNAPSHOT The leading global player in Traffic Enforcement





Operating Profit (EBIT) 12 Months Rolling MSEK



# BUSINESS UPDATE Continued strong profitable growth, Sensys Gatso 17% EBITDA margin



• Full Year EBITDA MSEK 84, up 41%

- Mostly driven by (US) TRaaS
- Higher Gross margin on TRaaS resulted in 41% overall margin

• Full Year EBIT MSEK 46, four times higher than last year (11)

# Proven TRaaS business model pushes growth





- Full year Total Sales MSEK 507, up 11%
- Full year TRaaS MSEK 248, up 14% and 49% of Net Sales in 2021
- Three new TRaaS contracts added in USA (plus three in 2022)
- School Zone speed enforcement programs restarted after COVID temporary closings


